





COVID -19 Cleaning Plan Pre-Start Required PPE **Pre-Start Tool Box** - Disposable overalls - Disposable P2 masks - All Staff must have completed Infection Control Training in COVID - 19 - Goggles - Cleaning staff should be informed to avoid touching their face, - Disposable nitrile gloves especially their mouth, nose, and eyes when cleaning. - Full arm gloves - Alcohol-based hand rub/washing of hands prior to donning PPE: surgical - Face shield mask, eye protection Required Materials - Impervious bag - Alcohol-based hand rub should be utililsed between removal of each - Impervious waste bag item during doffing of PPE: coveralls - Colour coded mop/buckets - DO NOT mix or dilute alcohol-based disinfectant. - Colour coded disposable cloths - Rings, watches, jewelry must not be worn. Long and loose hair must be - Colour coded hand buckets tied back. - Green/yellow sponge/scourer

Chemicals are selected carefully in consultation with employees, minimising the risk of hazards and contaminates. No unlabelled containers or bottles allowed on site. Chemicals must be clearly labelled in quantities of 5L or less.

Procedure

Solution Warehouse - Preparation of bleach solution

- 1. Face shield and full arm length gloves should be worn when preparing bleach solution.
- 2. Bleach solution should be diluted 1-part bleach, 20 parts water, made up daily, used mainly on hard, non-porous surfaces.

On Site - Setup

- 1. Wash hands thoroughly for 60 seconds.
- 2. After applying alcohol-based hand rub, put on overalls, gloves, and goggles.
- 3. Ensure working area is completely vacant.
- 4. Ensure access to working area is controlled, use signage & barricades if required.

Two Step - Decontamination Clean

- 1. Perform a thorough clean using detergent solution of all general and frequently touched surfaces.
- 2. Disinfect general surfaces, including but not limited to, damp dust all surfaces, walls, furniture and fittings, clean windows, sills and frames, mop floors.
- 3. Disinfect all frequently touched surfaces, including but not limited to: Door handles, bedrails, tabletops, light switches, elevator buttons, computer keyboards and mice, and telephones.
- 4. Allow 10 minutes of contact time.

Pack Up

- 1. Place mop heads in impervious bag and seal to be removed from site. (Do not shake bag).
- 2. Mop heads to be machine washed at Solution warehouse on highest temperature setting with standard household detergent. Dry completely before re-use.
- 3. Disinfect buckets and cleaning tools making sure to disinfect handles.
- 4. Once all equipment is disinfected and dry, pack away equipment in vehicle.
- 5. Place all disposable cleaning materials and waste in impervious bag to be disposed of offsite.

Clean up - Removal of PPE

- 1. With Gloves and boots still on, remove overalls from head to toe, making sure not to touch your face.
- 2. Place disposable overalls in impervious bag to be disposed of offsite.
- 3. Disinfect your boots using disposable cloths.
- 4. Carefully take off disposable gloves and place in impervious bag to be disposed of offsite.
- 5. Alcohol-based hand rub/washing of hands prior to removing mask and goggles goggles to be cleaned/disinfected and stored
- 6. Dispose of mask in impervious bag to be disposed of offsite.
- 7. Seal Impervious waste bag to be disposed of offsite (do not shake).
- 8. Alcohol-based hand rub/washing of hands
